Dear Mr. Li:

The Connecticut Light and Power Company (“CL&P”) and Yankee Gas Services Company (“YGS”), doing business as Eversource Energy (“Eversource”), and The United Illuminating Company (“UI”), Connecticut Natural Gas Corporation (“CNG”), Southern Connecticut Gas (“SCG”), collectively, UIL Holdings Company (“UIL”), collectively (the “Companies”) hereby resubmit their 2021 Update of the 2019-2021 Plan pursuant to Connecticut General Statutes Section 16-245m(d) filed on March 1, 2021 to include the DEEP Conditions of Approval filed on March 4, 2021.

Enclosed for the Department of Energy and Environmental Protection’s (“DEEP”) review are copies of the 2021 Update of the 2019 to 2021 combined Electric and Natural Gas Conservation and Load Management Plan (the “2019-2021 Plan”) and the 2021 Program Savings Document (“PSD”).

The Companies have worked closely with the Energy Efficiency Board consultants to develop the 2021 Plan update which reflect updated Company Budgets based on carry over/(carry under) from 2020 and any adjusted realization rates based on the latest Program Savings Document

(PSD) as agreed upon by both Energy Efficiency Board Consultants and the Evaluation Committee. The Energy Efficiency Board Meeting approved the 2021 Plan Update and PSD at the Energy Efficiency Board meeting held on February 10, 2021.

Table 1-1 from the 2021 Plan Update highlights the 2019-2021 Plan Savings and Benefits.
