**APPLICATION FORM:** This application must be filled out completely, truthfully and accurately. The customer or their authorized representative must sign, date, and submit this application along with the installation invoice (as outlined under Proof of Purchase) the specification sheet(s), an IRS W9 Form, and any other required documentation identified in this application.

**ELIGIBILITY:** Rebates are available to industrial, commercial, institutional, and agricultural electric customers of Connecticut Light & Power Company DBA Eversource Energy ("Eversource"). The United Illuminating Company ("UI") who have a commercial rate code on their electric service. Eligible equipment and products must be installed in the service territory of the participating utility. Residential customers may apply for common areas of multi-family housing.
