Public Input/Comments

John Cassiano requested that the HES co-pay be lowered to \$0 when HES visits are re-instated. He said that would help incentivize customer participation, which would be greatly needed to stimulate demand for the program.

Companies' plans for COVID-19 response

Mr. Araujo and Ms. Del Rosso provided a verbal update on all the Companies' current activities and planned Covid-19 contingency actions.

CARES Act potential resources for programs

It was noted that the Companies and DEEP had hosted a recent webinar which provided an overview of resources available to businesses in the energy efficiency industry in Connecticut. A verbal summary of those resources was provided at this meeting.

Update on DEEP Conditions of Approval

Mr. Riddle provided a verbal update on the status of the 24 Condition of Approval for the 2020 Plan Update.

Deep dive focus area on Residential Planning for May EEB meeting

Mr. Faesy suggested that the Residential deep dive be approximately 40 minutes in length. He suggested both a quantitative and qualitative approach to the deep dive. Mr. Faesy provided some options. Mr. Cowell said that FCM and RGGI funds for health & safety barrier mitigation had been used in other states. Mr. Araujo said that RGGI funds were used for fuel oil and propane homes under HES and HES-IE. Mr. Araujo noted that the topic of strategic electrification was a delicate issue with the EEB because some Board members had previously not supported the use of C&LM funds for electrification.

Public Comments

- John Cassiano he requested that the HES co-pay be lowered to \$0 when HES visits are reinstated.
- Leticia Colon she said she appreciated the training being offered by the Companies, but she noted that it was difficult to reach out to staff that had been furloughed to encourage them to participate in the training. She requested that the vendors be allowed to choose their own training. She said that the vendors were under great duress and were being asked to do certain work tasks without compensation. Ms. Del Rosso said that the Companies had not considered reimbursement for training-related activities, but she said she was open to receiving suggestions on that.
